The 2020 High Achievers Scholarships will provide the following:

1) A\$2,000 off international student tuition fees for Undergraduate and Postgraduate's degree for which the scholarship is awarded. to students who carry the nationality/citizenship of studying one of the programs listed below:

- Students must apply through VU Sydney's registered agent to be eligible for the scholarship.
- Students must enrol into, and undertake a full-time VU Sydney program (8 units per year).

**Note:** for the purpose of the scholarship, ONLY tuition fees will be covered. The scholarship does not included all other expenses such as incidental fees which vary across the courses, books, accommodation, OSHC among others.

VU Sydney reserves the right to revoke the scholarship where recipients are on the other scholarships.



#### FOR DIPLOMAS

Each semester, VU Sydney will award a A\$2,000 off international student tuition fees scholarship to students, based on previous academic performance and/or work experience, for up to two semesters.

The scholarship will apply from the first semester of study, and if students continue to perform well and demonstrate achievement of a minimum 65% credit average for the following second semester, they

will also receive a further A\$2,000 off international student tuition fees scholarship in each of those semesters. The scholarship will cover part of the tuition fees, and cannot be converted into other forms of payment or transferred to third parties.

#### FOR UNDERGRADUATE

Each semester, VU Sydney will award a A\$2,000 off international student tuition fees scholarship to students, based on previous academic performance and/or work experience, for up to six semesters.

The scholarship will apply from the first semester of study, and if students continue to perform well and demonstrate achievement of a minimum 65% credit average for the following 5 semesters (semesters 2, 3 4, 5 and 6), they will also receive a further A\$2,000 off international student tuition fees scholarship in each of those semesters. The scholarship will cover part of the tuition fees, and cannot be converted into other forms of payment or transferred to third parties.

Each semester, VU will award a A\$2,000 off international student tuition fees scholarship to students, based on previous academic performance and/or work experience, for up to 4 semesters.

The scholarship will apply from the first semester of study, and if students continue to perform well and demonstrate achievement of a minimum 65% credit average for the following 3 semesters (semester 2, 3 and 4), they will also receive a further A\$2,000 off international student tuition fees scholarship in each of those semesters. The scholarship will cover part of the tuition fees, and cannot be converted into other forms of payment or transferred to third parties.

- Assessments for scholarships will be conducted by ECA staff, who will decide if scholarships will be awarded to students.
- Scholarships are non-transferable and awarded for study at VU Sydney
- The total value of each scholarship is up to A\$2,000 off international student tuition fees for Diploma's, Undergraduate and Master's degree.
- For Diploma's: The scholarships for semester 2, will only be awarded if a minimum 65% credit average is maintained.
- For Undergraduate: The scholarships for semesters 2, 3, 4, 5 and 6 will only be awarded if a minimum 65% credit average is maintained.
- For Master's: The scholarships for semesters 2, 3 and 4 will only be awarded if a minimum 65% credit average is maintained.
- · Leave of absence is not permitted.
- Please note that the amount in the offer letter will be displaying the full fee. In order to claim the first scholarship of A\$2,000 student must submit signed a scholarship form altogether with the signed offer letter and proof of payment.
